Broken Rules Privacy Notice

We Broken Rules Interactive Media GmbH, Museumsplatz 1, Stiege 1, Top 2, 1070 Vienna ("Broken Rules" or "we"/"us") as the data controller take the protection of your personal very seriously. Therefore, we handle your personal data as confidential information and in compliance with the statutory data protection regulations as well as this Privacy Notice.

This Privacy Notice provides you with information on how we process your personal data when you use our games and other services ("Games").

1. What kind of your data we process

You are under no obligations to provide Broken Rules with the data we ask you for. However, if you do not provide your personal data, you will not be able to use Games and/or the features we provide. Should the provision of your personal data be mandatory by law, we will inform you separately thereof.

In order to provide you with our Games to its full extent, we will collect the categories of personal data set out below:

Use our Games:

When you use our Games, we may automatically collect your:

- game data such as game progress (i.e. which level you have reached), achievements (also known as trophies), completed events, saves of your game progress, virtual currency and statistics including the playtime or the use of the various features as well as the data associated with any bugs and malfunctions,
- IP address:
- device data and technical data such as device type, operating system, network connection type, screen resolution, device language, country, location and in case you use our Games via a mobile device your mobile carrier and/or Internet service provider; and
- *user preferences and settings*, such as game language, settings regarding ingame sound and music as well as auto save functions.

Test our Games:

When you sign up to be a game tester for our Games, which grants you early access to Games still in development, we may automatically collect, additionally to all data set out above under Use our Games, your:

- crash logs and statistical information related to your use of each early access
 Game,
- analytical data such as where users get stuck, and
- log information
- email information needed if we invite and communicate with you via email

2. Purposes of processing your data

We will process your personal data set out above for the purpose of:

- a. making our Games available;
- b. improving the features, design and gaming experience of our Games;
- c. troubleshooting such as detecting, preventing and investigating problems our Games cause:
- d. internal analytics;
- e. communicating with you and informing about our games; and
- f. internal reportings.

3. Legal bases of the processing

We process the categories of your personal data listed above on the following legal bases under the General Data Protection Regulation ("GDPR"):

- The performance of the *contract* we have concluded with you or the necessity to take steps at your request prior to entering into such an agreement, insofar as it is necessary (Article 6(1)(b) GDPR); or
- We process some the categories of personal data set out under point 1 on the basis of our *overriding legitimate interest* according to Article 6(1)(f) GDPR to provide you the best possible user experience, such as to ensure the security of our Games as set out under Point 2 above; or

- The necessity to comply with *legal obligations* to which we are subject (Article 6(1)(c) GDPR).

4. Age Limits

We do not knowingly collect or ask for any personal information from children. In case you can't confirm full legal capacity (fourteen), please do not provide us with any data about yourself, including name, address or email address.

If you wish that we delete data of individuals under the age of fourteen, please contact us at our contact information set out under point 8 below.

5. Transfer of your personal data

If you choose to take part in testing our Games, Apple will collect and send crash logs of, your personal information such as first name, last name and email address, usage information, and any feedback you submit to the developer. Apple retains TestFlight data for one year.

Thereafter, we will retain your personal data (i) as long as required under statutory retention obligations or (ii) as long as potential legal claims, where personal data is needed to raise or defend against the claim, are not yet time-barred.

7. Your rights in connection with your personal data

Under applicable law, you have the right to (under the conditions set out in applicable law):

- obtain confirmation as to whether and what kind of personal data we store about you and to request copies of such data;
- request rectification or erasure of your personal data;
- request us to restrict the processing of your personal data;
- object to the processing of your personal data;
- withdraw any consent previously granted for the processing of your personal data (withdrawing your consent does not affect the lawfulness of processing based on your consent before your withdrawal);
- request data portability; and
- lodge a complaint with the competent supervisory authority.
